**AGREEMENT**

IT IS UNDERSTOOD AND AGREED BY THE UNDERSIGNED THAT:

1. The alarm system is considered only as a convenience to the premised owner and an operational aid to the police or fire department.
2. The police or fire department shall not be held liable for any respond to an alarm
3. This application is subject to the approval of the Chief of Police or Fire Chief and may be revoked by the Village.
4. The permit holder shall allow inspection of the alarm system by authorized representatives of the police or fire department.
5. If the alarm is activated and the owner or authorized occupant is absent from the premises protected by the alarm, the police or fire department personnel shall be permitted to enter the premises without incurring any liability for the purpose of:
  - a Searching for intruders
  - b Extinguishing fires
  - c. Making necessary adjustments to the alarm system
6. The applicant shall designate a friend, neighbor, or relative to hold and have available to the police of fire department, a key to the premises and a key to the alarm system.
7. The applicant hereby acknowledges that:
  - a. He has read or is familiar with the Village General Ordinance regarding alarm systems.
  - b. He shall be responsible to pay all charges for false alarms.
  - c. The alarm system must be installed by a licensed individual or firm.
  - d. A permit must be issued before an alarm system is installed or altered.

THIS APPLICATION MUST BE FILED ALONG WITH THE PERMIT FEE OF \$25.00 EACH PERMIT. MAKE CHECKS PAYABLE TO THE INC. VILLAGE OF OYSTER BAY COVE.
